DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story enclosed building, three bays wide and two bays deep with a two story "L" shaped wing being two bays wide and three bays deep with a side balcony. All brickwork is of painted common bond. A round arched doorway with a three row header arch occupies the left bay with a large shop window to the right. In the right bay adjoining the property line is an enclosed gateway to the rear yard. It has a board and batten gate topped by an attractive panel with cut-out designs and is arched like the doorway. Second floor front windows are now of 1/1 sash with three row brick header arches with the top row protruding. Rear area windows are of 6/6 panes with wood lintels and sills. The front section is covered by a moderate slope metal "A" roof with a small chimney rising off center. There is a peaked, boarded-up dormer on the rear slope. The wing has a metal shed roof and a small chimney. The front is edged by what appears to be a three string brick cornice with the center row in the form of dentils, but on closer inspection, looks more like wood. The building rests on a low fieldstone foundation.
