DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story Federal townhouse of brick and is detached on the right side. It is three narrow bays wide and two bays in depth with a two story "L" shaped wing two bays long and one bay wide with a side balcony. There is a new one story addition. All brickwork is of painted common bond. An old, rather plain, doorway occupies the left bay and contains a six paneled door with an overlight and headed by a plain wooden lintel. It is framed by a paneled soffit and embrasure. All front and older rear windows are of 6/6 sash with wood lintels and sills. There are paneled doors with overlights on the rear. The front section has a rather steeply pitched metal "A" frame roof with a wide enclosed chimney rising from the right wall and the wing has a slight slope metal shed roof. A two string brick cornice supports the front and rear rooflines. The building rests on a low fieldstone foundation.
