DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a large 2-1/2 story townhouse of brick being detached on the right by a large side yard, and a tree shaded area extends to the rear of the block. It is three bays square with a two story "L" shaped wing, two bays wide and six bays long and has a two story, one bay square addition to the rear. There is a long side balcony. Brickwork is of unpainted common bond of an attractive light shade of red. The front door has a large oval glass panel framed by a rectangular section of moulding. Above this is a rectangular transom and moulded transom bar. This is topped by a moulded lintel with end blocks angled down to a square base, a design used on other homes in this block. There is a low peaked flat pediment over this lintel. All front windows are of 1/1 sash with lintels and pediments similar to the doorway and have paneled shutters. There is a bay window over the right bay trimmed with dentils, brackets and panels. All rear windows are of 6/6 sash with wood lintels and sills and louvered shutters. The doors are paneled and have three pane overlights. The front section has a low slope "A" frame roof while the wing and extension have metal shed roofs. A pair of chimneys linked at the base rises from either gable. The front roofline carries a simple box cornice. The house rests on a rather low field-stone foundation.
