DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick house ~~being~~ detached on the left side. It is three bays wide and two bays in depth with an "L" shaped wing two bays wide and four bays in depth with a side balcony. All brickwork is in common bond. The front doorway occupies the left bay and contains a glass paneled door and rectangular overlight with a decorative moulded transom bar. Hooded flat entablatures decorated with a row of small incised and moulded dentil forms and incised with Moline crosses in the architrave and supported by moulded brackets, head the doorway and first floor windows. Second floor front windows, also of 1/1 sash, have moulded lintels with square end blocks angled down to a square base like other homes in this area. Rear windows are of 6/6 sash with wood lintels and sills and the doors are paneled, topped by four pane overlights. The front section has a steep metal "A" frame roof with double flue enclosed chimneys rising from the gables. The wing has a metal shed roof with two small enclosed chimneys. The front section rear roofline is supported by a three string brick cornice and also possibly the front, but it is boxed in by a wooden cornice. The building rests on a low fieldstone foundation. A side driveway leads to a long narrow flower yard in the rear.
