**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a tall, two story brick detached building being four bays square with a two story "L" shaped wing four bays long and two bays wide with a side balcony. There is a newer two story extension to the rear and a one story extension on the side. All brickwork is of common bond. There are star end brace terminals on the sides. The first floor front has been rebuilt with the shop and the upper stories in the outer bays and large paned glass panels in the center. There are many miscellaneous business signs on and above the shop windows and those detract from an already ugly front. This front is in exact contrast to that of #413-415. Second floor windows on the front are of 2/2 sash with hooded and moulded flat entablature cornices trimmed only by a wide recessed panel in the architrave. The rear of the front section has a 6/6 sash window and the wing has newer 1/1 sash, all with wood lintels and sills. There are paneled doors in the wing but with no overlights. The front section roof slopes to the rear and the wing has a shed roof, both of metal. There are several small enclosed chimneys on both sections. The front roof cornice is moulded with fluted modillions under the soffit and the bays are separated and ended by fluted consoles with pendant shield motifs of incised designs. The building rests on a low foundation.
