DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick house of general shape and trim as #418 and is detached on the right side. It is three bays wide and two bays in depth with a two story "L" shaped wing being four bays long and two bays wide with an added side extension of rusticated cement blocks three bays long. There is a small side balcony in the last bay (past the extension). All brickwork is of painted common bond. A front doorway occupies the right bay and contains a glass over panels door and a rectangular transom with trim as on #418. A pillared porch with pedestals and dentil trim extends across the doorway and 1/1 sash windows. Second story windows are also of 1/1 sash and with moulded lintels with square end blocks angled down to a square base as on other houses in this block. Rear area windows are either of 1/1 or 2/2 sash on the original wing and are protected by louvered shutters. The front section has a steep metal "A" frame roof with twin flue chimneys enclosed in the gable walls. The wing has a metal shed roof with a small chimney at the end. The front section of the roof probably rests on a three string brick cornice but is boxed in on the front and concealed in the rear by the side wing extension. The building rests on a low fieldstone foundation. There is a long narrow flower yard to the rear.
