DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick attached house, four bays wide and two bays in depth with a two story "L" shaped wing being four bays long and two bays wide with a side balcony and a newer one story, one bay square extension. All brickwork is of painted common bond. The entranceway lies in the left bay and contains a glass paneled door with a round arched transom and attractive moulded transom bar. The whole is enclosed by a wide moulded architrave round arched at the top and crowned by a shield design. A low porch with iron railing leads to the entrance. The two center bays are occupied by a round arched triple window with fluted mullions topped by a sphere. The windows are headed by sections of small paned colored glass in wood muntins, separated from the lower sections by a row of thin dentils. This window is topped by a round brick arch with long voussoirs forming a keystone (similar to #422). The right bay has an enclosed passageway to the rear yard with a board and batten gate topped by a round arched wooden grill of a very attractive, cut-out design and a two row header arch. Front second story windows are of 1/1 sash and round arched windows with two row brick headers. Rear area windows are of 6/6 sash with wood lintels and sills. Doors are glass paneled with overlights. The front section roof is a moderate slope metal "A" frame with a double flue chimney rising off-center. The wing has a low slope metal shed roof. A three string brick cornice supports the front roofline. The building rests on a low fieldstone foundation. There is a long narrow flower garden extending to the rear.
