DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick building located on a corner. A former Federal style home, it has been altered so extensively that only the north gable wall remains intact. It is five bays wide and approximately three bays deep with a two story, three bay wide, two bay long, wooden extension to the left rear, and a two story, two bay wide and two bay long brick extension on the right rear, making the whole approximately square. The first floor is used as a grocery store with large plate glass windows and doors. There are living quarters on the second floor. Remaining window frames now have 1/1 sash. Brickwork is of common bond. There is some wood facing on the store-front and side. The front section has a steep slope "A" frame roof, hipped on the right side. An enclosed chimney extends from the left gable. A boxed cornice ends the front roof line. Roofing is either of metal or asphalt shingles.
