DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick building attached on the left side. It is two bays wide and three bays in depth with a two story "L" shaped wing, one bay wide and three bays long which is of later construction. Brickwork is of common bond. The first floor front living quarters have been converted into a barber shop with a plate glass window and door. Second floor front windows are of 2/2 panes with segmental brick arches. Side windows and those on the rear area are either 2/2 or 1/1 sash. The front section roof slopes to the rear. It is edged by a moulded cornice with small fluted modillions. The building rests on a rather low foundation. There is a small yard to the rear.
