DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story rectangular building detached on the right side and with an extension to the right from the right rear corner. The main building is three narrow bays wide and approximately eight bays long with the extension centered off the rear right corner--to the right, and which is four bays square. This was added behind the adjoining #507 as an ice cream factory by a former owner. It has newer wood lintels and 6/6 sash. To the rear of this is a 1-1/2 story, two bay square older building, possibly a former stable and has very old soft brick and 6/6 sash with two row header segmental arches. All brickwork is laid in common bond. The first floor front is occupied by a Victorian shopfront with a recessed central entrance of double doors with glass over panels and large plate glass show windows on either side. This is covered by a moulded cornice trimmed with a row of dentils and is framed by fluted pilasters with spaced square blocks covered with roundels. A row of small dentils trim the transom bars under the transoms. The second story front facade is ornamented by a central pediment with a row of dentils across the base, rising above the roofline and supported by two piers corbelled out from the front wall. The gable is adorned by a triangular section of square blocks containing roundels. The three windows between and beside these piers are of an unusual three part sash having the side quarters divided by vertical muntins. These are topped by high flat jack arches. The rear of the building has been sheathed with siding with only one double window left. The metal roof slopes to the rear with an enclosed chimney near the center. The front roof cornice is moulded and supported by very plain brackets with roundels in between on either side of the pediment. There is an "S" brace terminal on the left sidewall. The building rests on a low fieldstone foundation.
