DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story late Colonial brick home detached on the left side. It is three bays square with an "L" shaped wing of one bay wide and three bays long with a deteriorating side balcony and other woodwork. Front brickwork is laid in Flemish bond and contains a moulded brick watertable crossing just below the front windows and a three string belt course with the top row projecting from the others, a local building custom, crossing at the second story level. Rear area brickwork is in common bond. A simple entranceway lies in the right bay with a six paneled door headed by a four pane overlight and the soffit and frame are paneled. This is topped by a wood lintel with square end blocks carved with roundels, as are all front windows, which are now of 1/1 sash and with louvered shutters. Rear are windows have 6/6 sash with wood lintels and sills. Rear doors have glass over panels and with overlights. The front section has a moderate slope "A" frame roof with a wide enclosed chimney rising from the left wall. The wing has a low slope shed roof and both are of metal. Front and rear roof cornices are boxed. The house rests on a rather high fieldstone foundation and a herringbone brick pavement adds charcter to this old house. The end of this building abuts the side wing of #505.
