**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story brick detached Federal building containing two residences and a front room barbershop. It is four bays wide and two bays in depth with a two story, two bay wide, one bay deep, wooden extension behind #512 and a two story, full width brick wing of five bays in length and a side balcony to the rear of #514. Judging by the side brickwork, this was originally a 1-1/2 story building with the original section built of a salmon colored brick. All brickwork is laid in common bond. Entranceways occupy the center bays. #512 has a four paneled door with the top panels round arched while the door of #514 now has a large pane in the top section. These have one pane overlights and paneled soffits and frames. On either side are double windows, now of one sash, and Victorian styling. The center mullions and end frames have moulded projections at the heads and bases. They also have lugsills of wood. The windows are headed by flat brick arches. Second story front windows are of 2/2 sash with wood lintels and sills. Rear area windows are mostly 6/6 sash with wood lintels and sills. The doors have four panels and no overlights. The front section roof is of a moderate slope metal "A" frame with small square enclosed chimneys rising from the gables. The attics are lighted by small square, four pane windows. The wing of #514 has a metal, slight slope shed roof. The front roofline is supported by a two string brick cornice. The building rests on a rather low fieldstone foundation. There are lawn areas to the rear.
