DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story Federal period brick building now containing two residences and is detached on the right side. It is five bays wide and two bays in depth with two story "U" shaped wings approximately two bays square. There are balconies on the end of each wing. All brickwork is of common bond. Doorways occupy the end bays with an enclosed passageway to the rear yards occupying the center bay. Front doors are paneled and with single pane overlights and dentil trimmed transom bars. The passageway is fronted by a board and batten door/gate with an ornamental carved, wooden grill above. All front windows are now of 1/1 sash with louvered shutters and topped by segmental, two row header brick arches, as over the doorways. Rear windows are of 6/6 sash with wood lintels and sills. Rear doors are paneled and have one pane overlights. The front section has a rather steep "A" frame roof and the right wing has a shed roof--one section being shed and the other of "A" framing. All are of metal. A double flue chimney protrudes off center above the ridgeline. The front and rear rooflines are supported by three string brick cornices. The building rests on a moderately high fieldstone foundation.
