DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story detached pair of brick houses four bays wide and two bays in depth with a two story brick "T" shaped wing being three bays wide and two bays in depth with a rear balcony. All brickwork is in common bond. Entranceways occupy the end bays with paneled doors and single pane overlights. These are reached by three step brick porches with iron railings. All windows are of 2/2 sash except for the two on the first floor front. Rear doors have six panes over panels. The cornice along the front roofline is of Victorian design with decorative carved brackets with pairs of carved crescents in between, and the whole ended by massive sloping brackets topped by round globes on either side. The front section roof slopes to the rear and the wing has a slight slope "A" frame--both of metal. Small chimneys are enclosed on either side. The building rests on a moderately high foundation.
