DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story brick house detached on the left side and two bays wide and four bays in depth with a rear balcony. All brickwork is of common bond. An entrance-way occupies the left bay with a paneled door and one pane overlight with a dentil trimmed transom bar. All front windows are of 1/1 sash with segmental two row header brick arches, as over the doorway. Rear and side windows are of 2/2 sash with arches similar to the front. Rear doors are six panes over panels with an overlight on the first floor. The metal roof has a slight slope to the rear with three enclosed chimneys on the right side. The front roofline is edged by a triangular wooden Victorian cornice decorated by rows of pierced "V's", crosses-saltire, mouldings, and is supported by three carved brackets. The building rests on a rather high foundation. In the rear is a small dooryard patio.
