DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached brick structure holding two homes. It is four bays wide and two bays in depth with a "T" shaped wing divided into two shops. #619 has a two story section of two bays square with a flat roof and an enclosed side balcony. #621 has a 1-1/2 section, 2 x 1 bays in size with a shed roof. All brickwork is in common bond. Doorways occupy the end bays with doors containing glass over panels. Front and rear area windows are a combination of 1/1 and 6/6 sash with wood lintels and sills. A newer wide bay window fronting #619 has diamond panes in the top sashes. The "A" frame moderate slope roof of the front section is covered with metal, as are the wing sections, and it is supported on the front by a two string brick cornice. Small chimneys are enclosed in each end wall. The building rests on a rather high fieldstone foundation. #621 is fronted by a brick, herringbone patterned pavement.
