DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story corner brick building being three bays wide and two bays deep with an added, full-width, two story wing five short bays in depth. There is an enclosed rear balcony. To this building is added a one bay square, one story concrete block extension. The first floor is occupied by a shop with large paned windows and a corner entrance. On the second floor front and the exposed side are 6/1 sash with flat brick arches. The attic is lighted on the left side by two small windows. The front section has a moderate slope "A" frame roof with enclosed chimneys rising from each gable. The wing has a shed roof and both are of metal. The front roofline rests on a two string brick cornice. The building has a low foundation.
