DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#2 Clarke Place is a detached 2-1/2 story home with the first story of cut fieldstone and a frame upper area. It is approximately three bays square with a 2-1/2 story, two bay square rear wing section of the same materials and with a two story gallery. The right front N.W. corner is projected by the landmark tower consisting of a rectangular first story stone base topped by an octagonal, two story bay section crowned by a domed roof. On either side of the house are two story rectangular bay window sections. Upper stories are sheathed by shingles in regular, diamond shaped and fish scale patterns.

The entrance occupies the center bay with a period glass over panels door and is protected by a wide fieldstone porch with rounded and turned pillars supporting a hipped roof. All windows are of 1/1 sash and those on the first floor are headed by segmental stone arches.

The hipped roof of the house, covered by asphalt shingles, is further enhanced by hipped roof dormers on all sides and tall corbelled attached stone and brick chimneys with recessed panels. This mansion occupies a corner lot surrounded by lawns.
