**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#10 is a large detached 2-1/2 story frame mansion about three bays wide and five bays in depth with various projections, including a three story round tower at the right (west) front corner and two story bay sections on either side supporting large overhanging pediments. A two story gallery crosses the rear and left rear side. This house is sheathed with narrow Colonial style siding. The tower and bay window sections are covered by shingles in fish scale, random length and diamond shapes and the tower is capped by a tall, conical roof surmounted by a metal finial.

The entrance occupies the left bay with small double doors and a rectangular transom. To the left of this is a vertical pair of casement windows of leaded stained glass in floral and diamond motifs set in ovals. A Victorian wrap-around covered porch crosses the front and part of the right side with turned pillars, spindle cornice with fan shaped brackets and the small entrance pediment is adorned with a sunburst motif. The pediments of the bay sections are steep sloped and covered by slate and decorated at the top by incised and cut-out applied foliated designs. The front section slate roof is hipped and steep sloped and being joined by the pedimented projections. The rear section has a steep sloped slate "A" frame roof. A chimney rises from the peak of the short-hipped section and another from the rear of the wing. The house rests on a low fieldstone foundation. It is surrounded by lawn areas and large trees including tall pine framing it at each front corner.
