DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#110 is a 2-1/2 story detached brick house approximately two bays square with newer side and rear additions and a rear balcony. All brickwork is in common bond. A three part entrance occupies the right (west) bay with a glass over panels period door, leaded glass sidelights, and overlights having unusual intersecting caps ("bosses") in a rosette motif. A full-width covered porch is supported by Doric pillars. Front windows are double and all have 1/1 sash with two row header segmental arches.

The house has a very steep sloped pyramidal slate roof and a small chimney projects from the rear slope and side. This roof overhangs the walls and the projection is adorned with modillions. A double window dormer with a hipped roof lights the attic from the front.

The house rests on a low fieldstone foundation and is surrounded by lawn areas, shrubs and trees.
