DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#112 is a 2-1/2 story detached frame house being three bays wide and four bays in depth with a 2-1/2 story frame rear section being one bay deep and three bays wide with a rear balcony. All siding has been covered with a realistic wood grained aluminum siding.

A rather simple period door is off centered and the house is fronted by a covered porch with Doric pillars and turned banisters. There is an assortment of 1/1 windows such as a one story bay, two story bays on the front and side, front three section window, extra wide, and regular frame windows. Many are protected by louvered shutters.

The front section has a steep sloped pyramidal roof and the wing has a steep sloped "A" frame, all covered by metal. A triple flue chimney rises from the rear section. The attic is lighted from the front by a wide pedimented dormer window containing four small windows in a Palladian shape.

The house rests on a low fieldstone foundation and sets amid lawn areas, shrubs and tall trees.
