DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#116 is a detached 2-1/2 story brick house being three bays square with a two story brick bay window tower near the rear of the left (east) wall and a rear gallery. All brickwork is in common bond.

A plain entrance lies off center with a period glass over panels door and rectangular transom. The first floor is protected by a covered porch supported by Doric columns. All house windows are of 1/1 sash with segmental, two row brick header arches, except for a pair of vertical wood casements on the right side and two low leaded, stained glass windows done in a scroll design similar to the transoms of the office building at W. Second and Court Streets. The attic is well-lighted by a peaked dormer window projecting from each side of the steep sloped slate pyramidal roof. A corbelled chimney rises from the peak.

This house rests on a low fieldstone foundation and is surrounded by lawn areas and trees.
