DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#120 is a detached 2-1/2 story frame house approximately three bays square and framed on the front facade by two story bay window sections and another two story bay window section projects from the right (west) side. There is also a rear projection which supports a gallery. The house is sheathed on all sides by narrow Colonial style wood siding.

A glass over panels door occupies the center bay and the house is fronted by a covered porch supported by Doric columns. All windows are of 1/1 sash with most protected by louvered shutters. The attic is well lighted by a hipped dormer of double windows projecting from three sides of the steep sloped metal, pyramidal roof and a pediment crowning the right side bay also contains a window. The roof projects on all sides.

This house rests on a low fieldstone foundation and is surrounded by lawn areas and trees.
