DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#5 is a 2-1/2 story detached brick house three bays wide and two bays in depth with a two story brick "L" shaped wing two bays wide and four bays in depth with a side balcony and a narrow, two story brick dependency extension. All brickwork is in common bond. A newer door with a narrow overlight occupies the left (W) bay. All front windows are of 2/2 sash and rear windows remain 6/6 sash, all with wood lintels and sills. There is a four panel kitchen door. The attic is lighted by a small four pane window in each gable. The front section has a steep slope "A" frame roof resting on two string brick cornices and double flue enclosed chimneys rise from each side. The wing has a shed roof and both are of metal. This house rests on a low foundation (fieldstone) and is fronted by a herringbone patterned pavement. Floor beams are said to be pegged and there is a finely moulded and carved ballustrade and newel post (pegged beneath the floor) leading upstairs from the hall.
