**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a row of four, two story brick houses, eight wide bays in width and approximately four bays in depth with two story brick wings. End houses have "L" shaped wings two bays in depth and 1-1/2 bays wide with rear balconies. The center houses share a "T" shaped wing of the same proportions. Front entranceways occupy the left (E) bay of each house with glass panel doors and segmental arched transoms. To the right of each doorway is a two story brick bay window section with three narrow windows, all of 1/1 sash and two row brick segmental arches. The sides of these bays are recessed with additional small recessed panels between the second and third floor windows. First floor windows have transoms separated by a transom bar with channeled decor. Rear windows are of 2/2 sash with two row segmental brick arches as on the front and the wings have wood lintels and sills. A projecting moulded cornice with dentil trim caps the front facade including the bay windows and this is headed by a top wall section also including the bay windows decorated also by small recessed panels, as below, a three row section of corbelled dentils and ornate cast iron roof cresting. The metal roof slopes to the rear from the top of the front wall with small chimneys for each house. The building rests on a low fieldstone foundation with bricked-up cellar walls bringing the cellars mostly above ground with front entrances under the high porches.
