DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached brick pair of two story houses two bays wide and approximately five bays in depth with a two story brick "T" shaped wing three bays square beveled into the front section and with rear balconies. All brickwork is in common bond. Period doors occupy the outer bays with round arched transoms and these are approached by ornate cast iron porches with similar adjoining cellar entrance railings. Doorway arches are adorned with brick keystone and impost "block" sections. The wide first floor front windows have segmental brick arched transoms with dented transom bars and brick keystone sections. Second story front windows are in sets of three, round arched, and center windows are higher and wider. All front windows are of 1/1 sash and those on the rear area are of 2/2 sash with two row header brick segmental arches. The front section roof slopes to the rear and the wing roofs are rather flat. The front facade is capped by a "V" shaped Victorian cornice decorated with bands of moulding and incised crosses. The building rests on a low fieldstone foundation and is fronted by a brick pavement.
