**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#14 is a 2-1/2 story brick house detached on the left (E) side, three bays wide, two bays in depth with a two story brick "L" shaped wing being two bays wide and five bays in depth with a side gallery. The front facade is laid in Flemish bond and the rest in common bond. The front entranceway occupies the right bay with a newer door, paneled enframement, and narrow overlight. Front windows are now of 1/1 sash with flat brick arches of unusually short stretchers as above the doors. There is a 6/6 JIB window-door on the rear of the front section and wing windows are of 6/6 sash with wood lintels and sills. Rear doors have three pane overlights. The front section has a steep slope "A" frame roof of slate resting on three string brick cornices. A very wide enclosed chimney rises from the left gable and is pierced by a centered four pane window lighting the attic. The wing has a metal shed roof. This house sets on a rather high fieldstone foundation.
