**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a 2-1/2 story detached brick pair of houses four bays wide and three bays in depth with a full width two story brick wing, two bays in depth with enclosed rear balconies. All brickwork is in common bond. Simple front entrances occupy the inner bays with newer doors, paneled enframements, and narrow overlights. Front windows are of 2/2 sash with wood sills and moulded top lintels with bands of scallops, as above the doors. Rear area windows are all of 1/1 sash with wood lintels and sills. The attics are lighted by nearly full-sized 1/1 sash windows in each gable. The front section has a moderate slope asphalt shingle "A" frame roof resting on three string brick cornices and double flue enclosed chimneys with corbelled tops rise from each side. The metal wing roof slopes to the rear.

The houses set on a rather high fieldstone foundation.

NOVEMBER 1975 - A wood framing over a rear door has been discovered in the wing with "J. Himmell 1876."
