DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story brick pair of houses four bays wide and two bays in depth with a full width two story brick wing, two bays in depth and with a long rear balcony. All brickwork is in common bond. Simple entrances occupy the outer bays with newer doors, paneled enframements, and three pane overlights. Front windows of #21 are of 2/2 sash and #23 now has 1/1 sash, all with wood sills and moulded top lintels. Rear windows remain 6/6 sash with regular wood lintels and sills. The attic is lighted by two four pane windows in a gable. The front section has a moderate slope "A" frame roof resting on two and three string brick cornices and very wide enclosed chimneys rise from each side. The wing roof slopes to the rear and both are of metal. This pair of houses rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
