DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#24 is a very small proportioned and low 2-1/2 story detached brick house two bays square with a one story brick "L" shaped wing one bay wide and two bays in depth with a side roof overhang and a newer block extension. All brickwork is in common bond. There is a newer door in the left bay with a small 1/1 sash window to the right. On the second story front are two small 3/1 sash windows. The wing has 6/6 sash with no arches. The attic is lighted by two six pane windows in the right gable. The front section has a steep slope metal "A" frame roof and a small enclosed chimney rises on the right side. Newer formstone trim has been added around the door, the first floor window, and across the front at the base of the house. This building rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
