DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#25 is a small 1-1/2 story detached brick house four bays wide and two bays in depth with an old one story stone wing of full width and one bay deep. All brickwork is in common bond and has recently been restored including the grapevine pointing of colonial houses. The simple front doorway occupies the third bay from the left (W) with a four panel door, paneled enframing and narrow overlight. All house windows are now of 1/1 sash with wood lintels and sills except for the two peaked dormers on the front, which have 2/2 sash and the small gable windows with 4/4 sash. The front section has a very steep "A" frame roof resting on two string brick cornices and double flue enclosed chimneys rise from each side. The wing roof slopes to the rear with a tall chimney. The house rests on a low fieldstone foundation and is fronted by a herringbone patterned pavement.
