

DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a two story corner property attached on both ends and is of rectangular shape being five bays wide on Market Street and eight bays deep on E. All Saints Street. Brickwork is of painted common bond. The first floor has been considerably altered for commercial use but the second floor retains the original appearance with 6/6 sash and wood lintels and sills on the front and side facades. The lintels are decorated with Federal style square end blocks incised with roundels. Rather steep metal "A" frame roofs cover the Market and Saints Streets sides. There is a wide enclosed chimney on the north end of the building. A three string brick cornice supports the roof-lines on exposed sides. The building rests on a low foundation.
