DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#34 is a tall 2-1/2 story brick house detached on the left (E) side, three bays wide and two bays in depth with a 2-1/2 story brick "L" shaped wing two bays wide and three bays in depth and a side balcony and one story brick extension. All brickwork is in common bond. The front entrance occupies the right bay with a newer door, paneled enframement and three pane overhead. First floor windows are now of 1/1 sash with metal lintels, but the second story and rear windows retain 6/6 sash and wood lintels and sills. The attic is lighted by a small window in the left gable. The front section has a steep slope "A" frame roof resting on three string brick cornices with a wide enclosed chimney rising on the right side and a smaller one on the left side. The wing has a steep shed roof with a small attic window at the rear and both are of metal. The house rests on a low fieldstone foundation and bricked up cellar walls.
