DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#38 is a 2-1/2 story brick house detached on the right (W) side, approximately three bays square with a two story brick "L" shaped wing two bays wide and four in depth with a side balcony and a one story brick dependency. All brickwork is in common bond. The front entrance occupies the left bay with a newer glass door, paneled enframing and narrow overlight. All front windows are now of 1/1 sash with moulded top lintels. There is a double pair of 6+6 sash casement windows on the first floor of the wing and others are of 6/6 sash with wood lintels and sills. A newer door in the wing retains a three pane overlight. The attic is lighted by a rather large window in the right gable. The front section has a broad, moderate sloped "A" frame roof resting on three string brick cornices with a very wide enclosed chimney rising on the right side and a smaller one on the left. The wing has a moderate slope shed roof and both are of metal. This house rests on a low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
