DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#42 is a small two story frame house detached on the right (W) side, approximately two bays square with a two story frame "L" shaped wing 1-1/2 bays wide and three bays in depth with a rear balcony. Most of the building is sheathed in asbestos siding over the original clapboarding, still visible on the rear. A newer door occupies the right front bay and all house windows are of 2/2 sash except for 1/1 sash on the front of the first floor. The front section roof slopes to the rear and the wing has a shed roof. The front facade is crowned by a very ornate wooden cornice and frieze with a low pediment rising at the center. This whole section is trimmed by bands of ornate dentils and scallops with incised scrollwork in the tympanium of the pediment. Ornate brackets accent the ends of this pediment and ends of the cornice. The house rests on a low fieldstone foundation.
