DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a high detached two story pair of brick houses four bays wide and five bays in depth with a two story brick "T" shaped wing approximately three bays square. #52 has a long side gallery and a two bay deep frame extension. All brickwork is in common bond. Period doors with narrow transoms occupy the inner bays and all windows are of 1/1 sash with two row segmental brick arches and brick sills. The roof slopes to the rear and is fronted by a Victorian "V" shaped cornice decorated by a band of scallops. Carved brackets bearing crockets decorated with roundels divide and end the house lines. The building rests on a low fieldstone foundation but has high bricked-up cellar walls necessitating six step brick porches.
