DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached pair of 2-1/2 story brick houses similar to #56-58, four bays wide and approximately three bays in depth with a 1-1/2 story brick "T" shaped wing three bays wide and two bays in depth with side roof overhangs. All brickwork is in common bond. Newer doors with three pane overlights remain on the wing. All house windows are of 6/6 sash with wood lintels and sills and small four pane windows light the attics from each gable. The wing contains similar attic windows. Both the front section and wing have moderate slope "A" frame metal roofs with the front section resting on two string brick cornices with double flue enclosed chimneys rising at each end and at the rear of the wing. This pair of houses rests on a low fieldstone foundation.
