DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 2-1/2 story detached pair of brick houses four bays wide and approximately three bays in depth with a 1-1/2 story brick "T" shaped wing three bays wide and two bays in depth with side roof overhangs. All brickwork is in common bond. #74 retains an old four panel door, both have three pane overlights, and the entrances occupy the inner bays. The wing has newer doors but retains the three pane overlights. All house windows are of 6/6 sash with wood lintels and sills and a small four pane window lights the ~~the~~ attics from each gable. The wing also contains a small four pane attic window in each side of the end. Both the front and wing sections have moderate slope metal "A" frame roofs with the front resting on two string brick cornices. Double flue enclosed chimneys rise at each end with a large enclosed chimney at the end of the wing. The building rests on a low fieldstone foundation but brick cellar walls raise the cellar 1/2 above groundlevel. This is fronted by a brick pavement.
