DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a 1-1/2 story detached pair of brick houses four bays wide and two bays in depth with a 1-1/2 story brick "T" wing three bays wide and two in depth with side roof overhangs. All brickwork is in common bond. Front entrances occupy the inner bays with #78 retaining an old four panel door and both have three pane overlights. Wing doors are newer but retain three pane overlights. First floor house windows are of 6/6 sash with low "lie on your stomach" type casement windows now in 1/1 sash above, except for remaining 4+4 sash on the left rear side and all have wood lintels and sills. The front section attics are lighted by rather large 1/1 sash windows in each gable and the wing attic by two small four pane windows. Both the front sections and the wing have moderate slope metal "A" frame roofs with the front section resting on two string brick cornices and small enclosed chimneys rise from the ends. This building rests on a low fieldstone foundation but high brick cellar walls raise the cellar to 1/2 above ground level. This is fronted by a brick pavement.
