DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a wide 1-1/2 story pair of brick and stone houses detached on the right (W) side, six bays wide and two bays in depth with no wings except a newer frame shed extension. The front and sidewalls are common bond brick but the rear wall of rather small fieldstone appears to have been either the front or rear wall of an earlier building. This wall is in three joined sections with those on the ends being wider. Simple front entrances occupy the second bay from each end with old four panel doors and three pane overlights. Front and rear windows are of 6/6 sash with narrow frames, there is a right side 2/2 sash window, and the attic of #84 is lighted by two small 2/2 sash windows all with wood lintels and sills. There remains a pair of old two panel shutters with small cast iron fasteners on the front of #84. This building is covered by a very steep metal "A" frame roof supported by rough hewn timbers exposed at the rear soffit. Small chimneys are enclosed in each end. The front roofline has a small moulded wood cornice. The building sets on a high fieldstone foundation requiring seven and eight step front porches with small board and batten cellar doors beneath and is fronted by a brick pavement.
