DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#88 is a very tall 2-1/2 story house-store detached on the left (E) corner side, two narrow bays wide and two longer bays in depth with a newer, full-width, two story rear block extension. The front entrance to the former store on the first floor and to the high English basement occupies the left bay with four panel doors and the first floor door has a three pane overhead. This was formerly approached by a high wooden staircase leading to the grocery store. First and second story windows are of 6/6 sash with two small four pane windows in both the front and rear of the top story. The attic is lighted by a regular size 6/6 window in the left gable. A small 2+2 sash casement window lights the side of the cellar. The front section has a moderate slope metal "A" frame roof resting on two string brick cornices and a small enclosed chimney rises from the left side. The fieldstone foundation rises to a height of six ft. with the cellar at ground level.
