**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a detached row of four 2-1/2 story brick houses, nine bays wide and approximately three bays in depth sharing two small 1-1/2 story "T" shaped brick wings three bays wide and two bays in depth. All brickwork is in common bond. Simple front entrances occupy the outer bays of each pair with four panel doors and three pane overlights. An enclosed passageway to rear yards occupies the center bay. All windows on the front and rear of the front section are of 2/2 sash with those on the second floor front retaining top moulded lintels with a band of scallops as on #100 & 102. The first floor of the wings have mostly small 6/6 sash with the top sections lighted by mostly 4+4 "lie on your stomach" casement sliding on hinged windows. Most wing doors are newer. The front section and wings have metal moderate slope "A" frame roofs, all resting on two string brick cornices. Double flue enclosed chimneys rise at each end and center of the front section and at the rear of the wings. The building rests on a rather low fieldstone foundation, varying with the grade. It is fronted by a herringbone patterned brick pavement.
