DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a detached row of four frame houses of two stories, nine bays wide and approximately three bays in depth with the houses sharing two story "T" shaped frame wings two bays in depth and three bays wide. This clapboarded building with decorative wood "quoins" at the front cornices has been covered with asbestos siding on the front and asphalt shingles on the sides and rear. Most of the houses retain four panel doors and rectangular transoms and these are located in the second, fourth, seventh and eighth bays from the left (E) side. An enclosed passageway to rear yards occupies the center bay. Front windows are of 2/2 sash and wing windows are of 6/6 sash all in plain framing. The front section roof slopes to the rear and the wings have low "A" frames, all of metal. The front Victorian cornice is "V" shaped and ornamented with three small, equally spaced pediments, all decorated with bands of intricately carved and pointed dentils massed across the facade. Long fluted brackets end the cornice. This building sets on a rather high fieldstone foundation and is fronted by a herringbone patterned brick pavement.
