DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

This is a small, nicely proportioned, 1-1/2 story detached brick cottage located in the middle of a large garden patch (former brickyard). It is two bays wide and approximately three bays in depth. All brickwork is of a rather good facebrick and in common bond. An old four panel door with a three pane overhead occupies the left (S) bay. Windows are of old 6/6 sash headed by flat brick arches of shaped voussoirs. A small window formerly lighted the attic from the rear. A moderate slope "A" frame roof of metal rests on three string brick cornices with the bottom row in a dentil design. The gable end faces the street. This cottage rests on a low fieldstone foundation.

STATEMENT OF SIGNIFICANCE

A nicely proportioned small Federal brick cottage apparently in basically good condition. A later shed roofed front porch is deteriorating and hung with a big variety of the personal possessions of the present resident. The land is more valuable than the house and a good use of the house in the future would be to move it to an important location and restore it, which, because of its size, should not prove to be too expensive.
