**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

#136 is a 2-1/2 story detached corner brick house three bays wide and two bays in depth with a two story brick "L" shaped wing two bays wide and four bays in depth with a side balcony. All brickwork is in common bond. A newer door occupies the right (W) bay with a narrow, segmental arched transom. Front windows are of 1/1 sash with two row header segmental brick arches with infills decorated by incised scrollwork as above the door and low cellar windows. Side and rear windows are of 2/2 sash with wood lintels and sills. The attic is lighted by a small four pane window in each gable. The front section has a steep "A" frame roof resting on two string brick cornices and double flue enclosed chimneys rise from each end. The wing roof is rather flat and both are of metal. The house rests on a low fieldstone foundation.
