DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

A 2-1/2 story brick attached building, it is two bays wide and approximately eight bays in length. It has been extended to the rear several times and also to the south, with only the north wall a probable original. There have been several changes in the front facade. It is now faced with Flemish bond, unpainted brick, has a wide small paned fire department type overhead door and an adjacent paneled and small paned entrance door with a transom. On the second story are two pairs of double 6/6 sash windows separated by carved mullions and headed by a dentil trimmed transom bar, transoms of radiating panes and segmental brick arches. The front gable has a heavily molded cornice with returns. A lunette window lies just under the peak of the gable. Above this rests a square cupola with molded cornice, iron railing and an ogee curved  metal roof. This is adorned by a weathervane type metal figure of the fire company symbol -- Johnny Swamper, in early fireman's gear.

STATEMENT OF SIGNIFICANCE

The front facade of the original building has been attractively reconstructed with a light brick laid in Flemish bond and with Federal style features, blending wall with the area architecture. The cupola with the figure of "Johnny Swamper" is a Frederick landmark.
