**DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE**

This is a two story brick row of four houses detached on the left (E) side, eight bays wide and approximately three bays in depth sharing two, two story brick "T" shaped wings, one bay in depth and two bays wide with rear balconies. #150 & 152 now have newer extensions. All brickwork is in common bond. Four panel or newer doors occupy the outer bays of each pair of houses. All house windows are of 6/6 sash with wood lintels and sills, most with louvered shutters. The roof of the front section slopes to the rear and the wings have low "A" frame roofs. The simple front cornice is boxed and decorated by a band of dentils. Small cut brackets divide and end the bays. The building rests on a rather low fieldstone foundation and is fronted by a brick herringbone patterned pavement.
