DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#9 is a tall, 2-1/2 story brick house detached on the right (E) side, four bays wide and two bays in depth with a three story brick "L" shaped wing joining the front section roof at the halfway mark. This is approximately two bays square with a two story, two bay square brick extension and a newer block extension. All brickwork is in common bond. The simple front entrance occupies the second bay from the left with a newer door, paneled enframement and narrow overlight. All front windows are now of 1/1 sash with wood lintels and sills with the lintels decorated by square end blocks carved with roundels. The rear of the front section retains 6/6 sash, the first wing now has 1/1 sash and the second wing has 6/6 sash, all with wood lintels and sills and all house windows are protected by louvered shutters. The attic is lighted by two six pane windows in the right gable. The front section has a steep "A" frame roof resting on three string brick cornices and the sidewalls rise to form roof curtains with end buttresses. Double flue enclosed chimneys rise from each end. The wings have shed roofs and all are of metal. The house rests on a low fieldstone foundation and the front pavement is mostly of brick herringbone design.
