DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#15 is a 2-1/2 story brick house detached on the right (E) side, three bays square with a two story brick "L" shaped wing four bays deep and two bays wide with a side balcony and one story brick dependency with the shed roof resting on a two string brick cornice. All brickwork is in common bond. The front entranceway occupies the left bay with a newer Victorian door with a large oval glass pane, a paneled enframing, and narrow overlight. This is enclosed by Doric pilasters supporting a flat entablature. First floor front windows are now of 1/1 sash, but second story windows retain the old 6/6 sash, all with wood lintels and sills. These lintels are unusual for Frederick as they are decorated by two wide horizontal channels. Rear windows are also of 6/6 sash with wood lintels and sills. The front section has a moderate slope "A" frame roof resting on three string brick cornices. Wide four flue enclosed chimneys rise from each side. The left sidewall has been extended to form a roof curtain with an end buttress. The wing roof is rather flat and both are of metal. This house rests on a rather low fieldstone foundation and is fronted by a herringbone patterned brick pavement.
