DESCRIBE THE PRESENT AND ORIGINAL (IF KNOWN) PHYSICAL APPEARANCE

#18 is a 2-1/2 story brick house detached on the left (E) side, four bays wide and two bays in depth with a two story brick "L" shaped wing one bay wide and four bays in depth with a side balcony. All brickwork is in common bond and has been recently restored. The front entrance occupies the second bay from the left with a newer door, paneled enframing and narrow overlight. All front windows are now of 1/1 sash with one being widened and all have wood lintels and sills. Rear windows remain 6/6 sash with wood lintels and sills, and there are old four panel doors. The attic is lighted from the left gable by a small four pane window. The front section has a moderate slope "A" frame roof resting on three and two string brick cornices and double flue enclosed chimneys rise from each end. The wing has a shed roof and both are of metal. The house rests on a low fieldstone foundation.
